Dear Fenway CDC's Friends and Members:

Due to concerns surrounding the ongoing COVID-19 outbreak, our Fenway CDC staff will continue to work remotely and are accessible via phone and email. *Please visit* www.fenwaycdc.org for latest updates of our events and programs.

Based on recommendations from the Centers for Disease Control, MA Department of Public Health, and Boston Public Health Commission, we strongly advise residents of our buildings and neighbors to take precautions to protect our community's public health and safety. We recommend below steps to prevent the spread of the flu and other illnesses:

- 1. Wash hands frequently, for 20 seconds with soap and warm water. If this option is not available, use hand sanitizer (active ingredient of 60% alcohol or more).
- 2. If you have a fever or are experiencing flu-like symptoms, stay home and do not attend public gatherings until symptoms have subsided. Take medicine and see doctor if your health condition is serious.
- 3. When coughing or sneezing, use a tissue or your inner elbow to cover your mouth and nose. Wash hands immediately after. Throw tissue in trash bin.
- 4. Get a flu vaccine! It's not too late!

Keeping in mind solidarity with our community, please be respectful of all regardless of race, nationality, ethnicity, or class.
